The aggregate amount Rs. 9.80 lakh will be released as per the table on submission of bank mandate form (Annexure I) in the enclosed format and after registration in the website <https://pfms.nic.in> by the above mentioned organisations /institutes. However for Non Government organizations/private organizations advance release of funds may be considered based on indemnity bond/bank guarantee as per provision of General Financial Rules(Annexure II).

3. The activities will be carried out as per guidelines enclosed (Annexure III). The master plan should be prepared within 12 months as per the guidelines enclosed. The expert consultants may be engaged, if required for preparation of the Master plan.

4. The above organization should intimate this Ministry in advance about the awareness generation and training activities for this project.

5. The release of subsequent final installment amount will be considered after completion of activities of the project and on submission of following documents:

- (i) **Work order for preparation of master plan , detailed project reports and energy audit reports or the expenditure incurred on these activities**
- (ii) **5copies of master plan and two copies of each DPR**
- (iii) **Energy auditing report of the campus**
- (iv) **Utilization certificates**
- (v) **Audited statement of expenditure as per scheme norms.**
- (vi) **list of awareness generation and trainings activities organized including reports on proceedings**
- (vii) **Any other information/report**

7. The other terms and conditions for the sanction & release will be as per MNRE's above referred scheme/Administrative Approval 5/4/2013-14/SC dated 17th January, 2014.

8. The funds will be released under "Development of Solar Cities" scheme of MNRE and is debitible to Budget Head 2810- New and Renewable Energy, 02- Off-Grid/Distributed and Decentralized Renewable Power; 08-Other Renewable Energy Applications (Solar Cities, Green Buildings etc.) including Support to states; 31-Grants-in-aid General for the financial year 2016-2017.


