Session on: RTI Act- the 'Jaadu ki Chhadi'

Rights are those basic facilities available to any being for its survival and growth. One such right is the *Right to Information*. On 22 February 2020, the Human Rights and Equal Opportunities Cell in Collaboration with Department of Political Science conducted guest lecture on the RTI Act, at 10:30 am in Shalom. The lecture was delivered by Shri Avinash Prabhane, Member at Adl. Dist. Consumer Dispute Redressal Forum, Nagpur.

The event began with introductory remark by Dr. Yoel. Without further ado, Mr. Prabhane began his talk by sharing personal experiences and, thus, explaining both sides of RTI filing desks. The lecture was made more engaging by showing legal documents from real-life experience and concentrating more on the practical utilization of the Act rather than the written theory. Mr. Prabhane also spoke about the online portals for filing an RTI, and explained the process of appeals made and answered through video conferencing. From Gandhiji to a local Bihari boy, Mr. Prabhane gave examples of all types of people, belonging to whichever section of society, in order to emphasize on the availability and accessibility of the Act. Finally, Mr. Prabhane ended the lecture with a Q&A round wherein he solved queries of students, involving questions related to the latest amendment in the Act. The two-hour long guest lecture came to an end with Ms. Apoorva Verma proposing the Vote of Thanks. The whole event was compered by Ms. Aisha Khan and Mr. Yash Potey. Thus, an important guest lecture was successfully organized by the HREO Cell with the help of its student Volunteers.
